### 2024

**R v CH & Others:** Operation Utah – Fatima is currently instructed by Farley's Solicitors on a 7-month multi-handed pension fraud trial at Newcastle Crown Court.

**R v JL & Others (04/2024):** Operation Tyronic - Fatima was instructed by BKP Solicitors on a 6-week multi-handed aggravated burglary trial at Birmingham Crown Court.

**R v GH (08/2024):** Fatima secured an acquittal for her client who was charged with making threats to kill and an assault occasioning actual bodily harm. The jury deliberated for under two hours before unanimously acquitting the defendant. Fatima was instructed by Nicholas Rozee, The Johnson Partnership.

**R v IW (08/2024**): Following a 3-day trial at Stoke-on-Trent Crown Court, Fatima's client was unanimously acquitted on 3 counts of (1) Assault Occasioning Actual Bodily Harm, (2) Nonfatal strangulation and (3) Theft, in under 90 minutes of the jury retiring. Fatima was instructed by Muzir Waheed, Zak Law Solicitors

**R v DT & Others (05/2024)**: Fatima represented DT in a 4-day multi-handed production of cannabis trial at Leeds Crown Court. She was instructed by Mariam Sabha, The National Law Firm.

**R v JM (04/24):** Fatima successfully represented JM in a 4-day GBH trial at Leeds Crown Court. Following a successful half-time submission, the defendant was acquitted of all charges.

**R v RT (04/2024):** Fatima represented a defendant who was accused of and pleaded guilty to committing acts tending to pervert the course of justice. Although the crown placed the offence at its highest, following extensive mitigation, Fatima persuaded the court to impose a suspended period of imprisonment with rehabilitation activity requirement days and an unpaid work requirement. Fatima was instructed by Sadia Ali, The Johnson Partnership.

**R v AM (03/2024):** Following a 4 day trial at Burnley Crown Court, Fatima secured an acquittal for AM who was charged with 1 count of exposure, under s.66 (1) of the Sexual Offences Act 2003. The prosecution case against Fatima's client was put on the basis that he had allegedly exposed his genitals to an 83-year-old lady who suffered from Alzheimer's disease with dementia and an associated adjustment disorder. The trial involved conscientious assessments of credibility and detailed cross-examination of the prosecution witnesses, who were admitted as hearsay evidence. Fatima was instructed by Gary McAnulty, Fylde Law.

**R v DL (03/24):** Fatima was instructed by Eldwick Law for sentence following a plea to dangerous driving. Fatima persuaded the court to impose a suspended sentence and RAR days.

**R v LO (01/2024):** LO was charged with 1 count of possessing a bladed article, contrary to s.139 Criminal Justice Act 1988. Fatima made a successful submission of no case to answer, whereby the charge was dismissed, and the defendant was acquitted.

**R v TW (01/2024):** Fatima was instructed by Atta Rehman, Harris Solicitors on a 4 day trial at Lincoln Crown Court involving 4 counts of making indecent photographs of a child.

R v FG (01/24): Fatima was instructed by Black and Co Solicitors on a 2-day trial at Leicester Crown Court involving one count of PWITS Class B.

**R v GG (01/24):** Fatima was instructed by Tana at Carson Kaye Solicitors on a 2-day public order trial at Manchester Crown Court.

**R v DC & Others (09-12/2023):** Led by Sarah Day in a 10 week multi-handed human trafficking trial at Winchester Crown Court, instructed by Sukhy Ark at Abbey Law. The client was acquitted of conspiracy to facilitate travel with a view to exploitation under s2 Modern Slavery Act 2015

R v KB (12/23): Fatima was instructed by Aftaab, Altaf Solicitors in relation to 2 trials for an 18 year old defendant: (1) 5 day multi-handed GBH trial at Leeds Crown Court, (2) Possessing ammunition when prohibited at Bradford Crown Court and PWITS.

**R v MR (11/2023):** Fatima was instructed by Rees Clayton Solicitors on a 3 day burglary trial at Preston Crown Court.

**R v AC (10/2023):** Fatima was instructed by Omar Saleem at Lexis Solicitors for a 5 day ABH and aggravated burglary whilst in possession of a bladed article. On the day of trial, due to numerous difficulties, the crown offered no evidence.

On day 4 of the trial, the client was acquitted of all charges following the recovery of 2000+ personal workspace files belonging to the officer, which had not been reviewed.

R v LB & Others (08/23): Fatima was instructed by Govier Solicitors on a 4 day GBH trial at Stafford Crown Court.

R v LT (06-07/2023): Led by Gerard Hillman in a 6-week multi-handed child cruelty trial at Warwick Crown Court.

R v YC (07/2023): Instructed on a 4-day trial at Derby Crown Court: Complex Fraud involving the NHS.

**R v MK (06/23):** Instructed by Omar Saleem, Lexis Solicitors on a 5 day multi-handed robbery trial. The defendant was acquitted of all charges.

R v IK (05/23): Fatima was instructed by Drummond Solicitors. Following extensive mitigation, a suspended sentence and RAR days were imposed for 1 count of threats to kill in a domestic context.

R v SF (03/2023): Fatima represented the first defendant in a 4 day burglary and ABH trial, which led to acquittals on both counts.

**R v WM (02/2023):** Fatima was led by Andrew Alty, representing the first defendant on the indictment before HHJ Dodd. The defendant, who was one of six named defendants, was charged with conspiracy to produce Class B drugs. The trial lasted 7 weeks at Burnley Crown Court and involved the presentation of extensive CCTV and phone evidence.

**R v LC (01/2023):** Successfully defended in a trial involving one count of breaching a sexual harm prevention order. The client was acquitted.

**R v IM (01/2023):** Successfully co-defended in a 4-day trial at Leeds Crown Court: fraud and causing serious injury by dangerous driving.

**R v JM (2023)** – Instructed in a 3-day complex ABH/harassment trial involving a defendant with mental health difficulties.

R v RS (2023) - Instructed on a 2-day trial involving Possession of Class A drugs.

**R v MP (2023)** – Secured a community order for a defendant convicted of intentional strangulation.

R v AM (2023) – No evidence was offered on day 2 of a 5 day GBH trial.

**R v FO (2023)** – Secured a suspended sentence and unpaid work for a defendant convicted of Possession with intent to supply class B drugs.

### 2022

**R v MIA (12/2022):** Instructed as junior counsel on a 6-9 week complex fraud and money laundering trial involving 4 defendants at Bradford Crown Court. Following a successful abuse of process argument, the crown offered no evidence to all charges on the day of trial.

R v RL (11/2022): Instructed on a multi-handed Encrochat trial involving numerous complex issues.

**R v GB:** Instructed by Eldwick Law a 3-day trial involving 4 counts of possessing extreme images of animals.

**R v SJ:** Multi-handed GBH with intent resulting in serious injury.

**R v TW:** 3-day burglary trial at Bradford CC.

**R v AH:** Following successful mitigation for an offence of dangerous driving, the defendant received a short community order, avoiding a lengthy custodial sentence.

**R v BM:** 3-day burglary trial involving 2 defendants.

R v FR: Successful appeal against conviction and sentence
